We are thankful to Shri Mataji for Her blessings and grace and for Her appointment of additional LETA (Life Eternal Trust Australia) - LEPA Life Eternal Properties Australia (Pty Ltd) Trustee Directors to serve Our Mother and Sahaja Yoga.

Terms for LETA-LEPA Trustee Directors

Abiding by HH Shri Mataji's letter the updated LEPA Constitution is to create five-year terms for Directors.

The new updated status is that every five years the current Directors tenure will be reviewed.

Yogis nominated to be LETA-LEPA Trustee Directors

As guided and taught by HH Shri Mataji when selecting Trustees, Shri Mataji would first inquire about potential Yogis' candidacy for a Trustee role, their profession and relevant experience, standing in the collective, and how active they are doing Sahaja Yoga and positive contributions they have made. HH Shri Mataji would then decide on the candidates.

Our recent nomination process mirrors this by assessing Yogi's capability through eligibility criteria and then candidates proceed to vibrational selection which took place after Guru Puja at Balmoral.

The process was thorough and detailed commensurate with the responsibilities of the role.

There were 16 expressions of interest for the positions. Just prior to the selection one candidate reconsidered and asked that they should not proceed to vibrational selection. This resulted in 15 nominations being submitted for consideration.

The applications of 15 Yogis who were both men and women from all the States and Territories of Australia were included in the list of candidates that proceeded for vibrational selection held at Balmoral Guru Puja on July 16th.

LETA-LEPA Trustee Directors Vibrational Selection

The appropriate method of Vibrational checking was followed.

Fundamental to vibrational selection is the pre-check step where the collective are first asked to check the vibrations of five envelopes. Three of which have a photograph of HH Shri Mataji.

This foundation step has been used for the last 12 years for Sahaja leadership roles to demonstrate that the Yogis checking the envelopes have at that time established their connection to the param chaitanya and who are best placed to discern the Will of HH Shri Mataji.

Selecting members of the collective without this pre-check to check the envelopes undermines and diminishes the principle that the param chaitanya is the instrument of appointment.

Nomination process for additional LETA-LEPA Trustee Directors

The Current Trustee - Directors provided the names of the 15 candidates to a team of independent senior Yogis who hosted the vibrational selection process to surrender the outcome of the final determination of HH Shri Mataji's Will.

The Trustees had no role in the vibrational selection. There were 200 Yogis in attendance at Balmoral. 7 Yogis correctly selected Shri Mataji's three photographs from the five envelopes presented.

They then retired to Shri Mataji's cottage to check the vibrations of the 15 candidates in blank envelopes to seek Shri Mataji's Will for who should serve Her as a Trustee-Director.
