3 week Maharashtra Tour

The Trustees of India invited all Australians to join with their Indian brothers and sisters together and meet together at Chhindwara the birthplace of our Mothers in March of 2023 to celebrate the auspicious and holy Centenary of the Advent and the birth of HH Shri Mataji Nirmala Devi. We shared this with all the Australian and State Sahaja Yoga Leadership Councils and the Australian collective.

The question was also posed "***What did we all feel was the best gesture we could offer to HH Shri Mataji as a worthy celebration of the 100th anniversary***".

We all agreed. To bring as many new seekers to the feet of Shri Mataji so many more seekers may receive their self realisation and accept Shri Mataji's Advent.

The Trustees proposed that Music of Joy plan to come to India late March 2023 for a major Tour which arranged on a grand scale sufficient to give as many seekers as possible their self realisation. This work is almost completed as we are about to depart for an auspicious coming together in the holy land of India and to work to that outcome together as one family.

The Tour will first travel to Delhi to stay at Nirmal Dham and support some programs in Delhi. The Tour will then attend the 100th Advent Birthday celebrations in Chhindwarra before touring Maharashtra for a series of public programs and events ending in Mumbai.

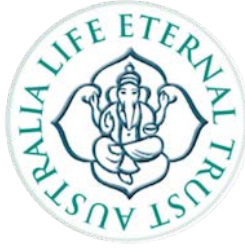
